WHEREAS in pursuance of the orders of the Hon'ble Supreme Court of India in I.A.No.182868 of 2019 in Civil Appeal Nos. 5467-5469 of 2017, dated the 6<sup>th</sup> December 2019 and based on the recommendations of the Delimitation Commission constituted under the Tami Nadu Delimitation Commission Act, 2017 (Tamil Nadu Act 23 of 2017), the certain amendments to the territorial wards of Madurai City Municipal Corporation have been published with ந.க.எண்.40396/2017/உ.வ.14 in Notification No.5 of the Madurai District Gazette, Extraordinary, dated the 3rd November 2021.

AND WHEREAS, the Delimitation Commission has submitted its recommendations for reservation of seats in the territorial wards of the Madurai City Municipal Corporation for the persons belonging to Scheduled Castes and Scheduled Tribes, Women belonging to Scheduled Castes and Scheduled Tribes and Women under section 4(1)(f) of the Tamil Nadu Delimitation Commission Act, 2017 (Tamil Nadu Act 23 of 2017).

NOW, THEREFORE, in supersession of Notification No.1 issued with ந.க.எண் 58840/2018/ஊ.வ.14/ in the Madurai District Gazette Extraordinary, dated the 21<sup>st</sup> May 2019 and in Notification No. 6 issued with ந.க.எண்: 40396/2017/ஊ.வ.14 in the Madurai District Gazette Extraordinary, dated the 6<sup>th</sup> November 2021 and in exercise of the powers conferred under sub-sections (4), (5) and (6) of section 5 of Madurai City Municipal Corporation Act, 1971 (Tamil Nadu Act 15 of 1971), read with rule 4 of the Tamil Nadu Town Panchayats, Municipalities and Corporations (Delimitation of Wards or Divisions and Reservation) Rules, 1996 and the powers delegated to the Commissioner, Corporation Madurai in G.O.(Ms)No.133, Municipal Administration and water Supply Department Notification No. 11(2)MW/1197(c-4)/96 at page 1 in Part II - Section 2 of the Tamil Nadu Government Gazette Extraordinary, dated the 6<sup>th</sup> June 1996 and based on the recommendation of Delimitation Commission, the Commissioner, Corporation of Madurai hereby reserves the following divisions for the persons belonging to Scheduled Castes and Scheduled Tribes, Women belonging to Scheduled Castes and Scheduled Tribes and Women in the Madurai City Municipal Corporation as specified in the Schedule below:-
