### MADURAI CITY MUNICIPAL CORPORATION

#### Notification of Delimitation Wards

WHEREAS the Delimitation Commission constituted under the Tamil Nadu Delimitation Commission Act 2017, (Tamil Nadu Act 23 of 2017), has submitted its recommendations for making certain modifications to the territorial wards of the Madurai City Municipal Corporation.

NOW, THEREFORE, in exercise of the powers conferred under section 49 of the Madurai City Municipal Corporation Act, 1971, (Tamil Nadu Act 15 of 1971) and the powers delegated to the Commissioner, Corporation of Madurai in G.O. (Ms) No.133, Municipal Administration and Water Supply Department, dated the 6<sup>th</sup> June 1996, published in Municipal Administration and Water Supply Department, Notification No. II/(2)/MW/1197/(c-4)/96 at page 1 in part – II Section 2 of the Tamilnadu Government Gazette, Extraordinary, dated the 6<sup>th</sup> June 1996 and based on the recommendation of Delimitation Commission, the Commissioner, Corporation of Madurai hereby makes the following amendments to Notification No. ந.க.எண்.40396/2017/வா.வ.14, dated 13<sup>th</sup> December 2018 published at pages 1-25 of the Madurai District Gazette, Extraordinary, dated the 14<sup>th</sup> December 2018:-

### THE AMENDMENTS

In the said Notification:-

- (1) at page 5, in the second column to the entry "West" against "Ward No. 17" in the first Column, the following proviso shall be added, namely, - "Provided that 'Telephone colony' is excluded from the ward",
- (2) at page 6, in the second column against the entry "west", against "Ward No. 18" in the first column, the expression "and Telephone colony" shall be added at the end,
- (3) at page 15,-
  - (a) in the second column against the entry "South" against "Ward No. 56" in the first column, the following expression shall be added at the end, namely:-

"Mill Line Colony, West Ponnagaram 12<sup>th</sup> street, New Jail Road, Sivanandha Road, Mothilal Main Road, West Ponnagaram Main Road",
  - (b) in the second column, to the entry "South" against "Ward No. 57" in the first column, the following proviso shall be added, namely:-

"Provided that Sivanandha Road, Mothilal Main Road and West Ponnagaram Main Road are excluded from the Ward",.
  - (c) in the second column, to the entry "South" against "Ward No. 58," in first column, the following proviso shall be added namely:-

"Provided that Mill Line Colony, West Ponnagaram 12<sup>th</sup> street and New Jail Road are excluded from the ward",.
